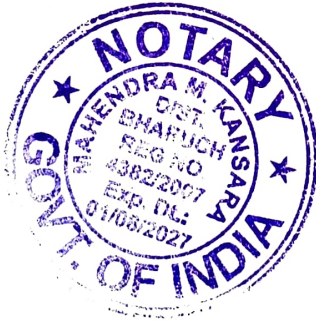
Resolution No. 80: To grant approval to the Sanskar Bharti Rungta Vidya bhavan.
